An ALTERNATIVE FUTURE for young people who have lived with violence



About Alternative Future

Alternative Future is an innovative project aimed at improving the lives and life chances of young people who have experienced violence. It is being delivered by a partnership of organisations across six European countries – Spain, Bulgaria, Scotland, Italy, Germany and Austria, and is funded under the Rights, Education and Citizenship programme of the European Union.

How the project carries out its work

The first step is to speak directly to young people who live in residential care settings, so that we can understand better how they perceive, understand and reflect on violence. This group of young people has been chosen as many of them will have direct experience of violence, through physical assault, sexual abuse, coercion by adults and aggression within peer relationships. The project team is speaking to young people in all six partner countries, to gather and reflect a diverse range of circumstances, experiences and contexts. The team is also gathering information from practitioners.



The information gathered from the young people and staff will be used to develop learning resources. These will build the capacity of staff to work more effectively with young people who have experience of violence and its continuing adverse effects. This information will be shared at a number of dissemination seminars – five or six in each participating country – after the support work with the young people, so we hope to reach a substantial number of practitioners and share the work of the project with them. Work with practitioners through the learning events should result in a number of identifiable actions to empower and support young people who have experience of violence, with particular emphasis on young people within the care system.

Informing policy at national and European level is a key part of project activity. We will hold an event where practitioners and partners will meet to share knowledge across the six nations and to learn from each other. We will also hold a seminar in each country, to which we will invite key decision-makers and influencers. A final European symposium will be held in Edinburgh near the end of 2017.

What we will produce

The main output of the project will be a Transnational Good Practice Catalogue, which will be the result of all the aforementioned activity.

Alternative Future will conclude its work at the end of 2017. We see it as the beginning, not the end, of a process. We hope to sow the seeds of better realising the rights of young people, of better understanding the effect of violence on their health and wellbeing, and of improving capacity in the workforce to support them during the life of the project. We want these seeds to take root and grow so that children's rights are respected and upheld in our care systems and throughout our services and so that young people move on from care with the same confidence and optimism as any other young person approaching adulthood.

Through our contact with policy makers we will seek to improve public policy in respect of children's and young people's rights, to secure commitment to continuous improvement in the life outcomes for young people who are care experienced, to ensure that gender perspective is taken into account whithin children rights policies and to work towards eliminating the difference in outcomes between them and other young people of their age.

The skills of practitioners who work with vulnerable young people will be improved and their capacity to respond sensitively and constructively enhanced. While we will reach a significant number of staff in the learning events, we aim to ensure that overall culture and practice in care settings improves as the staff who participate share their knowledge with their colleagues.
